Uyghur Forced Labor Disclosure Act of 2020

This bill requires issuers of securities to publicly disclose their activities related to China's Xinjiang Uyghur Autonomous Region. Specifically, issuers must disclose the importation of manufactured goods and materials that originated or are sourced from that region, as well as details about the commercial activity, gross revenue and net profits, and future import plans regarding these goods and materials. Furthermore, issuers must disclose whether any of these goods or materials are from forced labor camps.

Actions Timeline

- **Oct 1, 2020:** Received in the Senate and Read twice and referred to the Committee on Banking, Housing, and Urban Affairs.
- **Sep 30, 2020:** Considered under the provisions of rule H. Res. 1129. (consideration: CR H5063-5070)
- **Sep 30, 2020:** Rule provides for consideration of H.R. 4447, H.R. 6270 and H.R. 8319. The resolution provides for consideration of H.R. 4447 under a structured rulee with 90 minutes of general debate. The resolution provides for consideration of H.R. 6270, under closed rule and H.R. 8319 under a closed rule.
- **Sep 30, 2020:** DEBATE - The House proceeded with one hour of debate on H.R. 6270.
- **Sep 30, 2020:** Mr. McHenry moved to recommit with instructions to the Committee on Financial Services. (text: CR H5068)
- **Sep 30, 2020:** DEBATE - The House proceeded with 10 minutes of debate on the McHenry motion to recommit with instructions. The instructions contained in the motion seek to require the bill to be reported back to the House with an amendment to insert new text to the findings section of the bill about congressional and executive actions related to the Uyghur people.
- **Sep 30, 2020:** The previous question on the motion to recommit with instructions was ordered without objection.
- **Sep 30, 2020:** POSTPONED PROCEEDINGS - At the conclusion of debate on the motion to recommit with instructions, the Chair put the question on the motion and by voice vote, announced that the noes had prevailed. Mr. McHenry demanded the yeas and nays and the Chair postponed further consideration until a time to be announced.
