Summary (as of Apr 10, 2020)

Protecting Our Pharmaceutical Supply Chain from China Act of 2020

This bill requires the federal government to maintain a registry of certain foreign-sourced drugs, prohibits federal health care programs from purchasing drugs containing Chinese ingredients, requires drugs to be labeled for country of origin, and offers domestic manufacturing facility tax incentives.

Actions Timeline

- **Jul 13, 2020:** Referred to the Subcommittee on Oversight and Investigations.
- **Apr 10, 2020:** Introduced in House
- **Apr 10, 2020:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, Armed Services, and Veterans' Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Apr 10, 2020:** Referred to the Subcommittee on Health.
