### Route 66 Centennial Commission Act

This bill establishes the Route 66 Centennial Commission to honor Route 66 on the occasion of its centennial anniversary.

The Department of Transportation shall prepare a plan on the preservation needs of Route 66.

### Actions Timeline

- **Feb 7, 2019:** Received in the Senate and Read twice and referred to the Committee on Environment and Public Works.
- **Feb 6, 2019:** Ms. Norton moved to suspend the rules and pass the bill.
- **Feb 6, 2019:** Considered under suspension of the rules. (consideration: CR H1374-1377)
- **Feb 6, 2019:** DEBATE - The House proceeded with forty minutes of debate on H.R. 66.
- **Feb 6, 2019:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
