Summary (as of May 1, 2020)

Coronavirus Workers' Compensation for TSA Employees Act

This bill entitles certain employees of the Transportation Security Administration who are diagnosed with COVID-19 (i.e., coronavirus disease 2019) during a specified period to federal workers' compensation benefits.

Actions Timeline

- **Jun 1, 2020:** Referred to the Subcommittee on Transportation and Maritime Security.
- **May 1, 2020:** Introduced in House
- **May 1, 2020:** Referred to the Committee on Homeland Security, and in addition to the Committee on Education and Labor, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
