Summary (as of May 1, 2020)

Strengthening Unemployment Insurance for Coronavirus Impacted Workers and Students Act

This bill expands eligibility for pandemic unemployment assistance to include individuals with no recent attachment to the workforce (e.g., students), extends the availability of federal pandemic unemployment compensation, and provides federal pandemic unemployment compensation to individuals working reduced hours.

Actions Timeline

- **May 4, 2020:** Referred to the Subcommittee on Railroads, Pipelines, and Hazardous Materials.
- **May 1, 2020:** Introduced in House
- **May 1, 2020:** Referred to the Committee on Ways and Means, and in addition to the Committee on Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
