## Summary (as of Jan 22, 2019)

### Restoring the Public Trust Act

This bill sets forth provisions aimed at (1) prohibiting personal enrichment of federal employees, (2) rooting out conflicts of interest, and (3) increasing oversight and strengthening agencies responsible for rooting out corruption.

### Actions Timeline

- **Mar 4, 2019:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Mar 1, 2019:** Referred to the Subcommittee on Oversight.
- **Jan 22, 2019:** Introduced in House
- **Jan 22, 2019:** Referred to the Committee on Oversight and Reform, and in addition to the Committees on the Judiciary, Ways and Means, and House Administration, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
