Summary (as of Nov 19, 2019)

This resolution sets forth the rule for consideration of the Senate amendment to H.R. 3055 (Further Continuing Appropriations Act, 2020, and Further Health Extenders Act of 2019).

Actions Timeline

- **Nov 19, 2019:** Considered as privileged matter. (consideration: CR H8967-8969)
- **Nov 19, 2019:** DEBATE - The House proceeded with one hour of debate on H. Res. 708.
- **Nov 19, 2019:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 708, the Chair put the question on ordering the previous question and by voice vote, announced the ayes had prevailed. Mr. Cole demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question on H. Res. 708 until later in the legislative day.
