This concurrent resolution calls for an end to the consumption and trade of dog and cat meat and urges nations to adopt and enforce laws banning that trade.

- **Oct 31, 2019:** Introduced in House
- **Oct 31, 2019:** Referred to the Committee on Foreign Affairs, and in addition to the Committee on Agriculture, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
