## **Taxpayer Research and Coronavirus Knowledge Act of 2020**

This bill requires the Department of Health and Human Services (HHS), in coordination with specified federal agencies, to compile a public, searchable database of federal contracts, tax benefits, and other support for COVID-19 (i.e., coronavirus disease 2019) biomedical research and development, including information regarding the source and amount of such support. HHS must develop the database within one month and update it every two weeks.

### **Actions Timeline**

---

- **Sep 30, 2020:** Referred to the Subcommittee on Oversight and Investigations.
- **Sep 30, 2020:** Referred to the Subcommittee on Health.
- **Jun 22, 2020:** Introduced in House
- **Jun 22, 2020:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Armed Services, Veterans' Affairs, Science, Space, and Technology, the Judiciary, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
