Summary (as of Aug 2, 2019)

This joint resolution nullifies the rule issued October 24, 2018, that lessens requirements for states to obtain waivers from certain requirements of the Patient Protection and Affordable Care Act.

Actions Timeline

- **Aug 2, 2019:** Introduced in House
- **Aug 2, 2019:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
