Providing for consideration of the bill (H.R. 4) to amend the Voting Rights Act of 1965 to revise the criteria for determining which States and political subdivisions are subject to section 4 of the Act, and for other purposes, and providing for consideration of the resolution (H. Res. 326) expressing the sense of the House of Representatives regarding United States efforts to resolve the Israeli-Palestinian conflict through a negotiated two-state solution.

Summary (as of Dec 5, 2019)

This resolution sets forth the rule for consideration of H.R. 4 (Voting Rights Advancement Act of 2019) and H.Res. 326 (urging U.S. efforts to resolve the Israeli-Palestinian conflict through a negotiated two-state solution).

Actions Timeline

- **Dec 5, 2019:** Considered as privileged matter. (consideration: CR H9265-9271)
- **Dec 5, 2019:** DEBATE - The House proceeded with one hour of debate on H. Res. 741.
- **Dec 5, 2019:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 741, the Chair put the question on ordering the previous question and by voice vote, announced the ayes had prevailed. Mrs. Lesko demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question on H. Res. 741 until later in the legislative day.
- **Dec 5, 2019:** Considered as unfinished business. (consideration: CR H9279-9280)
- **Dec 5, 2019:** On ordering the previous question Agreed to by the Yeas and Nays: 228 - 196 (Roll no. 650). (consideration: CR H9279-9280)
