Summary (as of Jul 16, 2020)

Restoring Worker Power Act of 2020

This bill establishes various requirements related to temporary workers, including providing such workers with (1) wages that are not less than those of permanent employees performing substantially similar work, (2) descriptions of work assignments, and (3) itemized statements of wages.

Actions Timeline

- **Sep 8, 2020:** Referred to the Subcommittee on Oversight and Investigations.
- **Aug 7, 2020:** Referred to the Subcommittee for Indigenous Peoples of the United States.
- **Jul 16, 2020:** Introduced in House
- **Jul 16, 2020:** Referred to the Committee on Education and Labor, and in addition to the Committees on House Administration, Oversight and Reform, the Judiciary, Veterans' Affairs, Armed Services, Energy and Commerce, and Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
