Actions Timeline

- **Dec 17, 2019:** The House Committee on Rules reported an original measure, H. Rept. 116-353, by Mr. Morelle.
- **Dec 17, 2019:** Providing for the consideration of the Senate amendments to H.R. 1158, H.R. 1865; and for H. Res. 761. The Senate amendments will be debatable for one hour each. The previous question shall be considered as ordered without intervening motions or demand for division of the question. Upon adoption of H. Res. 765, H. Res. 761 shall be considered as adopted.
- **Dec 17, 2019:** Placed on the House Calendar, Calendar No. 62.
- **Dec 17, 2019:** Considered as privileged matter. (consideration: CR H10309-10312)
- **Dec 17, 2019:** DEBATE - The House proceeded with one hour of debate on H. Res. 765.
- **Dec 17, 2019:** POSTPONED PROCEEDINGS - At conclusion of debate on H. Res. 765, the Chair put the question on ordering the previous question and by voice vote, announced the ayes had prevailed. Mr. Cole demanded the yeas and nays and the Chair postponed further proceedings until later in the legislative day.
- **Dec 17, 2019:** Considered as unfinished business. (consideration: CR H10312-10314)
- **Dec 17, 2019:** On ordering the previous question Agreed to by the Yeas and Nays: 220 - 192 (Roll no. 683). (consideration: CR H10312-10313)
