This resolution sets forth the rule for consideration of H.Res. 755 (impeaching the President for high crimes and misdemeanors).

The resolution (1) designates certain individuals to be admitted to the Hall of the House of Representatives, during consideration of H.Res. 755; (2) after adoption of H.Res. 755, makes it in order to consider in the House a resolution appointing and authorizing managers for the impeachment trial, if offered by the chair of the House Committee on the Judiciary; and (3) prohibits any other resolution incidental to impeachment relating to H.Res. 755 from being privileged during the remainder of the 116th Congress.

The chair of the Committee on the Judiciary may insert in the Congressional Record, within five legislative days after its adoption, such materials as the chair may deem explanatory of (1) H.Res. 755, and (2) the resolution appointing and authorizing managers for the impeachment trial.

### **Actions Timeline**

- **Dec 18, 2019:** Considered as privileged matter. (consideration: CR H12115-12130)
- **Dec 18, 2019:** POINT OF ORDER - Mr. Scalise rose to raise a point of order against H.Res. 767 on the ground that the report accompanying the resolution fails to specify the waiver of a particular point of order, and is thus in violation of clause 6(g) of rule 13. The Chair advised the gentleman that he was not stating a proper point of order.
- **Dec 18, 2019:** DEBATE - The House proceeded with one hour of debate on H. Res. 767.
- **Dec 18, 2019:** On ordering the previous question Agreed to by the Yeas and Nays: 229 - 197 (Roll no. 693). (consideration: CR H12129-12130)
- **Dec 18, 2019:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 228 - 197 (Roll no. 694).(text: CR H12115)
- **Dec 18, 2019:** On agreeing to the resolution Agreed to by recorded vote: 228 - 197 (Roll no. 694). (text: CR H12115)

- **Dec 17, 2019:** Introduced in House
- **Dec 17, 2019:** The House Committee on Rules reported an original measure, H. Rept. 116-355, by Mr. McGovern.
- **Dec 17, 2019:** The question of adoption of the resolution, as amended shall be divided between the two articles. The amendment in the nature of a substitute printed in the bill shall be considered as adopted After adoption of H. Res. 755, it shall be in order without intervention of any point of order to consider in the House a resolution appointing and authorizing managers for the impeachment trial if offered by the chair of the Committee on the Judiciary or his designee.
