This resolution sets forth the rule for consideration of H.R. 535 (PFAS Action Act of 2019).

Actions Timeline

- **Jan 8, 2020:** Considered as privileged matter. (consideration: CR H23-30)
- **Jan 8, 2020:** DEBATE - The House proceeded with one hour of debate on H. Res. 779.
- **Jan 8, 2020:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 779, the Chair put the question on ordering the previous question and by voice vote, announced the ayes had prevailed. Mrs. Lesko demanded the yeas and nays and the Chair postponed further proceedings until later in the legislative day.

- **Jan 8, 2020:** On ordering the previous question Agreed to by the Yeas and Nays: 225 - 193 (Roll no. 2). (consideration: CR H49-50)
