Summary (as of Jan 25, 2019)

Savings Through Security Act

This bill provides appropriations to the Department of Homeland Security for the procurement and deployment of infrastructure, technology, and manpower to secure the international border between the United States and Mexico.

The bill also requires specified federal agencies to (1) report on costs associated with expenditures on unauthorized aliens, and (2) remit to the Treasury certain savings that are attributable to the funds provided by this bill to secure the international border between the United States and Mexico.

Actions Timeline

- **Mar 5, 2019:** Referred to the Subcommittee on Immigration and Citizenship.
- **Mar 1, 2019:** Referred to the Subcommittee on Worker and Family Support.
- **Feb 13, 2019:** Referred to the Subcommittee on Border Security, Facilitation, and Operations.
- **Jan 28, 2019:** Referred to the Subcommittee on Health.
- **Jan 25, 2019:** Introduced in House
- **Jan 25, 2019:** Referred to the Committee on Appropriations, and in addition to the Committees on Education and Labor, the Judiciary, Homeland Security, Agriculture, Ways and Means, and Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
