Justice is Not For Sale Act of 2020

This bill addresses various provisions related to the operation and administration of prisons, detention centers, and other correctional facilities, such as banning for-profit prisons, imposing requirements on financial and communication services available to inmates, and requiring alternatives to detention for family units apprehended under immigration authorities.

Actions Timeline

- **Sep 24, 2020:** Referred to the Subcommittee on Border Security, Facilitation, and Operations.
- **Sep 24, 2020:** Referred to the Subcommittee on Oversight, Management, and Accountability.
- **Aug 11, 2020:** Introduced in House
- **Aug 11, 2020:** Referred to the Committee on the Judiciary, and in addition to the Committees on Energy and Commerce, Financial Services, and Homeland Security, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
