Summary (as of Aug 14, 2020)

David Dorn Act of 2020

This bill increases criminal penalties for rioting and related acts, such as inciting or organizing a riot.

Specifically, this bill increases the maximum term of imprisonment for such offenses from 5 to 10 years. Additionally, if a fine is imposed for an offense, the bill sets a minimum fine amount of \$1,000.
