Summary (as of Jan 28, 2019)

Promoting Access to Diabetic Shoes Act

This bill allows a nurse practitioner or physician assistant to fulfill documentation requirements for coverage, under Medicare, of special shoes for diabetic individuals. Under current law, such requirements may be satisfied only by a physician.

Actions Timeline

- **Jan 29, 2019:** Referred to the Subcommittee on Health.
- **Jan 28, 2019:** Introduced in House
- **Jan 28, 2019:** Sponsor introductory remarks on measure. (CR E98-99)
- **Jan 28, 2019:** Referred to the Subcommittee on Health.
- **Jan 28, 2019:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
