Summary (as of Jan 28, 2019)

This bill prohibits making funds, resources, or fees available to any federal agency to implement or enforce Executive Order 13780 and Presidential Proclamation 9645, which suspended individuals from several countries of concern, including Chad, Iran, and Libya, from entering the United States. The Proclamation also provided for enhanced U.S. vetting capacities.

Actions Timeline

- **Mar 25, 2019:** Referred to the Subcommittee on Immigration and Citizenship.
- **Feb 13, 2019:** Referred to the Subcommittee on Border Security, Facilitation, and Operations.
- **Jan 28, 2019:** Introduced in House
- **Jan 28, 2019:** Referred to the Committee on the Judiciary, and in addition to the Committees on Foreign Affairs, Homeland Security, and Intelligence (Permanent Select), for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
