## Summary (as of Mar 14, 2019)

### Excellence in Mental Health and Addiction Treatment Expansion Act

This bill increases the number of states that may participate in two-year Medicaid demonstration programs that improve access to community mental health services. It also extends the two-year term for existing state demonstration programs by two years.
