Summary (as of Sep 17, 2020)

Masks for Students Act

This bill requires that a specified Federal Emergency Management Agency (FEMA) policy relating to public assistance remain in effect to provide cloth facial coverings to public schools (kindergarten through 12th grade) that provide in-person learning during the coronavirus emergency period.

The *coronavirus emergency period* is the period beginning on March 13, 2020, and ending on the later of (1) the last day on which a presidential declaration of emergency under the Robert T. Stafford Disaster Relief and Emergency Assistance Act with respect to the coronavirus (i.e., the virus that causes COVID-19) is in effect, or (2) the last day on which a presidential declaration of national emergency under the National Emergencies Act with respect to the coronavirus is in effect.

Actions Timeline

- **Sep 18, 2020:** Referred to the Subcommittee on Economic Development, Public Buildings, and Emergency Management.
- **Sep 17, 2020:** Introduced in House
- **Sep 17, 2020:** Referred to the House Committee on Transportation and Infrastructure.
