Providing for consideration of the resolution (H. Res. 826) expressing disapproval of the Trump administration's harmful actions towards Medicaid; providing for consideration of the bill (H.R. 2474) to amend the National Labor Relations Act, the Labor Management Relations Act, 1947, and the Labor-Management Reporting and Disclosure Act of 1959, and for other purposes; and providing for consideration of the bill (H.R. 5687) making emergency supplemental appropriations for the fiscal year ending September 30, 2020, and for other purposes.

This resolution sets forth the rule for consideration of H.Res. 826 (urging, among other things, that the Centers for Medicare & Medicaid Services withdraw recent guidance regarding the approval of block grants under Medicaid demonstration waivers), H.R. 2474 (Protecting the Right to Organize Act of 2019), and H.R. 5687 (Emergency Supplemental Appropriations for Disaster Relief and Puerto Rico Disaster Tax Relief Act, 2020).

- **Feb 6, 2020:** DEBATE - The House proceeded with one hour of debate on H. Res. 833.

Res. 833, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Burgess demanded the yeas and nays and the Chair postponed further proceedings on the question on ordering the previous question until a time to be announced.
- **Feb 6, 2020:** Considered as unfinished business. (consideration: CR H869-870)
- **Feb 6, 2020:** On ordering the previous question Agreed to by the Yeas and Nays: 224 - 194 (Roll no. 39).
