## Summary (as of Oct 2, 2020)

### Payroll Support Program Extension Act

This bill extends authority through March 31, 2021, for the Department of the Treasury to provide financial assistance to passenger air carriers, cargo air carriers, and contractors of passenger air carriers for the continuation of payment of employee wages, salaries, and benefits during the COVID-19 (i.e., coronavirus disease 2019) pandemic.

### Actions Timeline

- Oct 5, 2020: Referred to the Subcommittee on Aviation.
- Oct 2, 2020: Introduced in House
- Oct 2, 2020: Referred to the Committee on Financial Services, and in addition to the Committees on Transportation and Infrastructure, and the Budget, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
