Medicare Mental Health Access Act

This bill expands the definition of "physician," for purposes of the Medicare program, to include a clinical psychologist with respect to the furnishing of qualified psychologist services.

- **Jan 30, 2019:** Introduced in House
- **Jan 30, 2019:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jan 30, 2019:** Referred to the Subcommittee on Health.
