This resolution condemns transnational white supremacist extremism, supports law enforcement and intelligence agencies in their efforts to stop white supremacist acts of terror, and urges the Department of State to add violent foreign white supremacist groups to the foreign terrorist organization list.

### Actions Timeline

---

- **Mar 10, 2020:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Mar 3, 2020:** Introduced in House
- **Mar 3, 2020:** Referred to the Committee on Foreign Affairs, and in addition to the Committees on the Judiciary, and Intelligence (Permanent Select), for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
