Summary (as of Oct 1, 2020)

The Heroes Act

This bill provides additional appropriations, modifies existing programs and requirements, and establishes new programs to address the continued impact of COVID-19 on the economy, public health, state and local governments, individuals, and businesses.

Actions Timeline
