## Summary (as of Apr 1, 2019)

### Marketplace Certainty Act

This bill expands eligibility for additional cost-sharing reductions that apply to certain enrollees of qualified health plans. Specifically, it increases the income thresholds under which plan holders receive such cost-sharing reductions and increases the percentage of the shared costs paid by the plan at each income threshold.

### Actions Timeline

- **Apr 1, 2019:** Introduced in Senate
- **Apr 1, 2019:** Read twice and referred to the Committee on Health, Education, Labor, and Pensions.
