Summary (as of Feb 13, 2019)

Settlement Agreement Information Database Act of 2019

(Sec. 2) This bill requires executive agencies to submit information regarding settlement agreements to a public database. Specifically, an agency must submit information regarding any settlement agreement (including a consent decree) entered into by the agency related to an alleged violation of federal law. If an agency determines that information regarding an agreement must remain confidential to protect the public interest, the agency must publish an explanation of why the information is confidential.

- **Feb 13, 2019:** Considered as unfinished business. (consideration: CR H1557)
- **Feb 13, 2019:** Passed/agreed to in House: On motion to suspend the rules and pass the bill, as amended Agreed to by recorded vote (2/3 required): 418 - 0 (Roll no. 84).
- **Feb 13, 2019:** On motion to suspend the rules and pass the bill, as amended Agreed to by recorded vote (2/3 required): 418 - 0 (Roll no. 84). (text: 02/11/2019 CR H1500-1501)
- **Feb 13, 2019:** Motion to reconsider laid on the table Agreed to without objection.
- **Feb 11, 2019:** Ms. Hill (CA) moved to suspend the rules and pass the bill, as amended.
- **Feb 11, 2019:** Considered under suspension of the rules. (consideration: CR H1500-1502)
- **Feb 11, 2019:** DEBATE - The House proceeded with forty minutes of debate on H.R. 995.
- **Feb 11, 2019:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Ms. Hill (CA) objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was considered as withdrawn.
- **Feb 6, 2019:** Introduced in House
- **Feb 6, 2019:** Referred to the House Committee on Oversight and Reform.
