Summary (as of Feb 11, 2021)

Hadiya Pendleton and Nyasia Pryear-Yard Gun Trafficking and Crime Prevention Act of 2021

This bill makes trafficking in firearms a stand-alone criminal offense.

A person who commits or conspires to commit a gun trafficking offense is subject to criminal penalties—a prison term of up to 20 years (or up to 25 years, if the person also acted as an organizer), a fine, or both.

Actions Timeline

- **Apr 23, 2021:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Feb 11, 2021:** Introduced in House
- **Feb 11, 2021:** Referred to the House Committee on the Judiciary.
