This resolution expresses the sense of the House of Representatives that the federal government has a duty to develop a holistic agenda to respond to racial injustice, unemployment, the COVID-19 (i.e., coronavirus disease 2019) pandemic, and climate change.

The resolution further outlines the goals of this agenda to build a society with greater racial, economic, and gender justice; dignified work; healthy communities; and a stable climate. Additionally, the resolution identifies efforts to support these goals.

- **Feb 8, 2021:** Referred to the Subcommittee on Water Resources and Environment.
- **Feb 8, 2021:** Referred to the Subcommittee on Aviation.
- **Feb 8, 2021:** Referred to the Subcommittee on Railroads, Pipelines, and Hazardous Materials.
- **Feb 8, 2021:** Referred to the Subcommittee on Highways and Transit.
- **Feb 8, 2021:** Referred to the Subcommittee on Environment and Climate Change.
- **Feb 5, 2021:** Introduced in House
- **Feb 5, 2021:** Referred to the Committee on Education and Labor, and in addition to the Committees on Energy and Commerce, Transportation and Infrastructure, Natural Resources, and Agriculture, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
