The resolution also condemns companies that continue to operate in Russia and provide financial benefits to the Putin regime that enable his ability to continue waging war in Ukraine.

Finally, the resolution commands companies that have already suspended operations in or withdrawn from markets in Russia in response to the Putin regime's unlawful invasion of Ukraine.
