## Expediting Federal Broadband Deployment Reviews Act

This bill requires the National Telecommunications and Information Administration to establish an interagency strike force to increase specified agencies' prioritization of reviews for communications use authorizations on federal property. A *communications use authorization* is an easement, right-of-way, lease, license, or other authorization to locate or modify a communications facility on certain public land.

### Actions Timeline

- **Mar 25, 2021:** Referred to the Subcommittee on Conservation and Forestry.
- **Mar 16, 2021:** Referred to the Subcommittee on National Parks, Forests, and Public Lands.
- **Feb 16, 2021:** Referred to the Subcommittee on Communications and Technology.
- **Feb 15, 2021:** Introduced in House
- **Feb 15, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Natural Resources, and Agriculture, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
