Bills considered under the rule are debatable for one hour. The rule provides that H. Res. 1096 is adopted and amends H. Res. 188 by striking May 13, 2022 and inserting June 10, 2022.
- **May 10, 2022:** Placed on the House Calendar, Calendar No. 76.
- **May 10, 2022:** Considered as privileged matter. (consideration: CR H4764-4774)
- **May 10, 2022:** DEBATE - The House proceeded with one hour of debate on H. Res. 1097.
- **May 10, 2022:** DEBATE - The House proceeded with further debate on H. Res. 1097.
- **May 10, 2022:** On ordering the previous question Agreed to by the Yeas and Nays: 218 - 203 (Roll no. 143). (CR H4773)
