This resolution provides for consideration of H.R. 6531 (addresses funding for areas of persistent poverty), H.R. 7309 (reauthorizes through FY2028 and expands programs under the Workforce Innovation and Opportunity Act and also revises workforce investment, vocational rehabilitation, employment, training, and literacy programs for eligible individuals), and S. 2938 (designates the federal building and U.S. courthouse located at 111 North Adams Street in Tallahassee, Florida, as the Joseph Woodrow Hatchett United States Courthouse and Federal Building).
