This resolution calls on elected officials, faith leaders, and civil society leaders to condemn anti-Semitism in all forms. It also calls for renewed efforts to combat anti-Semitism domestically, globally, and online.

- **May 18, 2022:** UNANIMOUS CONSENT - Mr. Cohen asked unanimous consent that his motion to suspend the rules and agree to H. Res. 1125 be withdrawn. Agreed to without objection.
- **May 18, 2022:** Mr. Cohen moved to suspend the rules and agree to the resolution, as amended.
- **May 18, 2022:** Considered under suspension of the rules. (consideration: CR H5123-5126)
- **May 18, 2022:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1125.
