This resolution calls on the President to embrace the goals and provisions of the Treaty on the Prohibition of Nuclear Weapons and make nuclear disarmament the centerpiece of U.S. national security policy. It also calls on the United States to lead a global effort to prevent nuclear war.

Actions Timeline

- **Jun 16, 2022:** Introduced in House
- **Jun 16, 2022:** Referred to the Committee on Foreign Affairs, and in addition to the Committee on Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jun 16, 2022:** Referred to the Subcommittee on Asia, the Pacific, Central Asia and Nonproliferation.
