Summary (as of Jul 5, 2022)

This resolution condemns the Supreme Court's holding in *Dobbs v. Jackson Women's Health Organization* (that there is no constitutional right to abortion) and expresses a commitment to instituting judicial reform and supporting access to abortion and the communities affected by the Court's ruling. It also urges the executive branch to advance reproductive justice.

Actions Timeline

- **Nov 1, 2022:** Referred to the Subcommittee on the Constitution, Civil Rights, and Civil Liberties.
- **Jul 5, 2022:** Introduced in House
- **Jul 5, 2022:** Referred to the Committee on the Judiciary, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
