## Summary (as of Feb 23, 2021)

### EAGLES Act of 2021

This bill reauthorizes the National Threat Assessment Center (NTAC) within the U.S. Secret Service.

It reauthorizes the functions of NTAC through FY2025 and expands them to include the establishment of a national program on targeted school violence prevention.

### Actions Timeline

- **Apr 28, 2021:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Feb 23, 2021:** Introduced in House
- **Feb 23, 2021:** Referred to the Committee on the Judiciary, and in addition to the Committee on Education and Labor, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
