Summary (as of Apr 19, 2021)

This resolution condemns the actions taken by the governments of China and Hong Kong to put in place national security legislation that violates the freedoms and rights guaranteed to the people of Hong Kong. (Hong Kong is a part of China but, by agreement, has operated a legal and economic system largely separate from China's.)

Actions Timeline

- **Apr 19, 2021:** Mr. Meeks moved to suspend the rules and agree to the resolution.
- **Apr 19, 2021:** Considered under suspension of the rules. (consideration: CR H1927-1930)
- **Apr 19, 2021:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 130.
- **Apr 19, 2021:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
- **Apr 19, 2021:** Considered as unfinished business. (consideration: CR H1943-1944)
- **Apr 19, 2021:** Passed/agreed to in House: On motion to suspend the rules and agree to the resolution Agreed to by the Yeas and Nays: (2/3 required): 418 - 1 (Roll no. 121). (text: CR H1927)
