- the federal government should use laws and diplomatic influence to stop ongoing economic harms to the global South; and
- it is the duty of the federal government to issue reparations, including for slavery and colonialism.

### **Actions Timeline**

---

- **Nov 1, 2022:** Referred to the Subcommittee on the Constitution, Civil Rights, and Civil Liberties.
- **Sep 20, 2022:** Introduced in House
- **Sep 20, 2022:** Referred to the Committee on Foreign Affairs, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Sep 20, 2022:** Referred to the Subcommittee on Africa, Global Health, and Global Human Rights.
