Res. 1377, the Chair put the question on adoption of the resolution and by voice vote, announced that the ayes had prevailed. Mrs. Fischbach demanded the yeas and nays and the Chair postponed further proceedings until a time to be announced.
- **Sep 22, 2022:** Considered as unfinished business. (consideration: CR H8080-8081)
- **Sep 22, 2022:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 216 - 215, 1 Present (Roll no. 450).
- **Sep 22, 2022:** On agreeing to the resolution Agreed to by the Yeas and Nays: 216 - 215, 1 Present (Roll no. 450). (text: CR H8069-8070)
- **Sep 22, 2022:** Motion to reconsider laid on the table Agreed to without objection.
- **Sep 21, 2022:** Introduced in House
- **Sep 21, 2022:** The House Committee on Rules reported an original measure, H. Rept. 117-483, by Mr. McGovern.
- **Sep 21, 2022:** Resolution provides for 30 minutes of general debate with one motion to recommit for each bill.
