## Summary (as of Feb 26, 2021)

### Taxpayer Research and Coronavirus Knowledge Act of 2021

This bill requires the Department of Health and Human Services (HHS) to coordinate with specified federal entities to compile a public database of federal contracts, tax benefits, and other support for COVID-19 (i.e., coronavirus disease 2019) biomedical research and development. HHS must develop the database within one month and update it every two weeks.

- **Feb 26, 2021:** Introduced in House
- **Feb 26, 2021:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Armed Services, Veterans' Affairs, Science, Space, and Technology, the Judiciary, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Feb 26, 2021:** Referred to the Subcommittee on Health.
