Ghost Guns Are Guns Act

This bill broadens the definition of *firearm* for purposes of federal firearms laws.

Specifically, it includes as a firearm any combination of parts designed or intended to be used to convert a device into a firearm and from which a firearm may be readily assembled.

Actions Timeline

- **Apr 28, 2021:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Mar 1, 2021:** Introduced in House
- **Mar 1, 2021:** Referred to the House Committee on the Judiciary.
