Actions Timeline

- **Dec 6, 2022:** Introduced in House
- **Dec 6, 2022:** The House Committee on Rules reported an original measure, H. Rept. 117-590, by Mr. McGovern.
- **Dec 6, 2022:** The resolution provides for consideration of H.R. 3648, under a structured rule and H.R. 7946, under a structured rule. The resolution waives the requirement of clause 6(a) of rule XIII for a two-thirds vote to consider a report from the Committee on Rules on the same day it is presented to the House with respect to any resolution reported through the remainder of the 117th Congress.
- **Dec 6, 2022:** Placed on the House Calendar, Calendar No. 155.
- **Dec 6, 2022:** Considered as privileged matter. (consideration: CR H8759-8762)
- **Dec 6, 2022:** DEBATE - The House proceeded with one hour of debate on H. Res. 1508.
- **Dec 6, 2022:** The previous question was ordered without objection.
- **Dec 6, 2022:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 1508, the Chair put the question on agreeing to the resolution and by voice vote, announced that the ayes had prevailed. Mrs. Fischbach demanded the yeas and nays and the Chair announced that further proceedings on agreeing to the resolution would be postponed.
- **Dec 6, 2022:** Considered as unfinished business. (consideration: CR H8762-8763)
- **Dec 6, 2022:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 215 - 201 (Roll no. 501).
