Actions Timeline

- **Dec 21, 2022:** Introduced in House
- **Dec 21, 2022:** The House Committee on Rules reported an original measure, H. Rept. 117-660, by Mr. McGovern.
- **Dec 21, 2022:** Rule provides for one hour of debate on each measure. Also provides for a motion to recommit H.R. 9640 and a motion to commit S. 1942. H. Res. 693 and H. Res. 1434 are adopted. Provides for the Majority Leader or a designee that the House suspend the rules as though under clause 1 of rule XV with respect to multile measures.
- **Dec 21, 2022:** Placed on the House Calendar, Calendar No. 169.
- **Dec 21, 2022:** Considered as privileged matter. (consideration: CR H9968-9969)
- **Dec 21, 2022:** DEBATE - The House proceeded with one hour of debate on H. Res. 1529.
- **Dec 21, 2022:** The previous question was ordered without objection.
- **Dec 21, 2022:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 1529, the Chair put the question on adoption of the resolution and by voice vote, announced that the ayes had prevailed. Mrs. Fischbach demanded the yeas and nays and the Chair postponed further proceedings until a time to be announced.
- **Dec 21, 2022:** Considered as unfinished business. (consideration: CR H9972)
- **Dec 21, 2022:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 216 - 193 (Roll no. 531).(text: CR H9968)
- **Dec 21, 2022:** On agreeing to the resolution Agreed to by the Yeas and Nays: 216 - 193 (Roll no. 531). (text: CR H9968)
