Ban Conflicted Trading Act

This bill prohibits a Member of Congress or certain congressional officers or employees from (1) purchasing or selling specified investments, (2) entering into a transaction that creates a net short position in a security, or (3) serving as an officer or member of any board of any for-profit entity.

Actions Timeline

- **Apr 29, 2021:** Referred to the Subcommittee on Commodity Exchanges, Energy, and Credit.
- **Mar 3, 2021:** Introduced in House
- **Mar 3, 2021:** Referred to the Committee on Financial Services, and in addition to the Committees on Agriculture, and House Administration, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
