Rim of the Valley Corridor Preservation Act

This bill adjusts the boundary of the Santa Monica Mountains National Recreation Area in California as depicted on a specified map to include the Rim of the Valley Unit.

The Rim of the Valley Unit, and any lands or interests acquired by the United States and located within its boundaries, shall be administered as part of the recreation area.

The addition of the Rim of the Valley Unit to the recreation area shall not affect the operation, maintenance, or modification of water resource facilities or public utilities within the unit.

Actions Timeline

- **Oct 18, 2022:** Committee on Energy and Natural Resources. Reported by Senator Manchin under authority of the order of the Senate of 10/14/2022 with an amendment in the nature of a substitute. With written report No. 117-181.
- **Oct 18, 2022:** Placed on Senate Legislative Calendar under General Orders. Calendar No. 532.
- **Jul 21, 2022:** Committee on Energy and Natural Resources. Ordered to be reported with an amendment in the nature of a substitute favorably.
- **Jun 23, 2021:** Committee on Energy and Natural Resources Subcommittee on National Parks. Hearings held.
- **May 20, 2021:** Introduced in Senate
- **May 20, 2021:** Read twice and referred to the Committee on Energy and Natural Resources. (Sponsor introductory remarks on measure: CR S3197)
