Ensuring Second Amendment Freedoms are Executed Timely Act

This bill allows a licensed gun dealer, manufacturer, or importer to transfer a firearm to an unlicensed person if a submitted background check remains incomplete after three calendar days (currently, three business days).

Actions Timeline

- **May 18, 2021:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Mar 11, 2021:** Introduced in House
- **Mar 11, 2021:** Referred to the House Committee on the Judiciary.
