RTP Full Funding Act of 2021

This bill revises provisions regarding the recreational trails program of the Department of Transportation (DOT).

Specifically, the bill requires

- DOT to estimate the total amount of nonhighway recreational fuel taxes received by the Department of the Treasury and transferred to the Highway Trust Fund;
- the Federal Highway Administration to establish financial management information system codes for certain motorized and non-motorized use projects, including single and diverse use projects;
- DOT to reserve amounts of the state-apportioned funds for administrative, research, technical assistance, and training expenses to carry out the recreational trails program; and
- states to obligate a specific amount of reserved funds each fiscal year for the recreational trails program.

Actions Timeline

- **Mar 12, 2021:** Referred to the Subcommittee on Highways and Transit.
- **Mar 11, 2021:** Introduced in House
- **Mar 11, 2021:** Referred to the Committee on Transportation and Infrastructure, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
